CLUB CARD DESCRIPTIONS

- **Snow Dough** is available for all Club Cards. Snow Dough allows you to put money on the Club Card to purchase anything from the resort.
- The **Sunset Club Pass** allows you to ski from 2pm-9pm Thursday, Friday, Saturday, and holiday evenings.
- The **Night Club Pass** allows you to ski from 4pm-9pm Thursday, Friday, Saturday, and holiday evenings.
- The **Club Season Pass** allows you to ski all season, all day/night, anytime. This discount is available to all Night Club Pass holders with a minimum night club membership of one year during the 2006-2007 ski season.
- We offer a few **Sunset/Night Club Add-ons** to increase the value of your club pass. The **Equipment Valet** ensures that your equipment is safe while inside the base lodge. The **Unlimited Helmet Rental** enables you to avoid head injuries while skiing or riding. The **Daylight Advantage Card** offers a discounted rate for day skiing (Adults \$36 midweek, \$46 weekend and holidays; Students \$24 midweek, \$36 weekend and holidays). The **Mountain Adventure Park** enables you to ice skate or snow tube on Friday & Saturday evenings from 4pm-9pm. **THE CLUB ADD-ONS ARE NOT AVAILABLE FOR CLUB SEASON PASS HOLDERS.**

CLUB CARD GUIDELINES

- All applicants under the age of 18 must have the signature of a legal guardian on the reverse of this application before submitting to the Group Sales Office.
- Passes will not be issued without full payment and a completed application.
- Night Club Lessons for your group's reserved night will be held at 5:00pm. Individual Night Club lessons will be held at 6:00pm.
- If a Club Card is forgotten the Club Card member will receive a free lift ticket (no more than three per season). If a Night Club card is lost there will be a \$10.00 charge to receive a new pass, and the lost pass will be voided. **CARDS ARE NOT TRANSFERABLE.**
- In the event that your school has a snow day and it is announced over the radio/television, Club Card holders may present the cards to the Group Sales Window to receive a \$15.00 lift ticket for the day.

Notice:

1. Skiers and ski lift passengers are governed by the New York State SAFETY IN SKIING CODE, Article 18 of the New York General Obligations Law.
2. BEFORE AFFIXING YOUR PASS/TICKET or allowing any pass/ticket to be affixed to your person, your attention is directed to a posted "WARNING TO SKIERS" which has been displayed where your pass/ticket was purchased.
3. The Safety in Skiing Code requires you to seek out, read and understand the "WARNING TO SKIERS" before you decided to participate in the sport of skiing.

"WARNING TO SKIERS"

Downhill skiing, like many other sports, contains inherent risks including, but not limited to the risk of personal injury, including catastrophic injury, or death, or property damage, which may be caused by variations in terrain or weather conditions; or surface or subsurface snow, ice, bare spots or areas of thin cover, moguls, ruts, bumps; or other persons using the facilities; or rocks, forest growth, debris, branches, trees, roots, stumps; or, other natural objects or manmade objects that are incidental to the provision or maintenance of a ski facility in New York State. New York law imposes a duty on you to become apprised of, and understand, the risks inherent in the sport of skiing, which are set forth above, so that you may make an informed decision of whether to participate in skiing notwithstanding the risks. New York law also imposes additional duties upon you, to which you must adhere, for the purpose of avoiding injury caused by any of the risks inherent in skiing. If you are not willing to assume all of these risks and abide by all of these duties, you must not participate in skiing at this area.

Management is not responsible for lost passes/cards/tickets, and passes/cards/tickets may be revoked without refund, at any time, by the management for misconduct or nuisance caused by the holder. Passes/tickets must be attached securely and visibly. I agree that all disputes and/or lawsuits under this contract and/or from my use of the facilities at Ski Windham shall be litigated exclusively in the Supreme Court of the State of New York, County of Greene, or in the United States District Court for the Northern District of New York.

RELEASE:

I have read and understand the NOTICE printed above and on reverse side. I have read, reviewed and understand the "WARNING TO SKIERS" posted at this ski area. I signify that I am aware of and understand the risks inherent in the sport of skiing as set forth on the "WARNING TO SKIERS."

I agree that this acknowledgment shall be for the entire term of the pass/card or documents received.

For their entire term, I relinquish my right to a refund of the purchase price of the pass or other documents purchased that is allowable under the Safety in Skiing Code for those persons unwilling to ski because of the risks of the sport or the duties imposed upon skiers by law.

NOTE: No refunds will be given for Season Passes, Frequent Skier Cards, or Night Club Cards for any reason. Personal checks and credit cards will be accepted for payment. Night Club Cards must be worn at all times while on property of Windham Mountain.
